**1.4 Opening Remarks**

At our last meeting we revised the Terms of Reference of the Commission with the purpose of taking this to the AGM for approval. At this meeting I would like to spend a little more time on this item to identify the roles that we need to run the Commission and ultimately the sport.

Since our last meeting there has been much discussion about the Stewart Grand Prix Road Running Series. Previously this had been handled outside the Commission. With the resignation of Geoff Wightman I assumed responsibility for this hoping to integrate it with the developments worked on by Mike Johnston and thereby constitute an integrated road running season. The old GP members of Geoff Wightman, Gary Condie, Fiona Curr, Ross Cunningham, John McDonald and Tom Ferrington were invited. GW and GC did not reply and RC turned down the invitation. Michael Johnston, Ron Morrison and Alex Jackson attended from the Commission. The results is the paper "Scottish Athletics Road Running 2010 and Beyond" that I would like discussed tonight.

One other item that I would like to discuss is finance as it includes some changes to contributions made by athletes to representative races.

Freya Murray and Laura Kenney finished 9<sup>th</sup> and 29<sup>th</sup> respectively in the Senior Women's race, Andrew Lemoncello 29<sup>th</sup> in the Senior Man's, Matthew Gillespie and Callum Hawkins 14<sup>th</sup> and 19<sup>th</sup> respectively in the U20 race, Beth Potter 25<sup>th</sup> in the Women's U20 race and Stephenie Twell 11<sup>th</sup> in the Women's U23 race. All won medal in the team races.

The first 5 of these were dealt with as follows:-

- a) RRCC2009-30: AJ – 6/4 stage relays: A meeting had taken place today between RM, AJ, Ross Cunningham, Martin Hyman and Alex McEwan. The event will run over the course used previously with the same start and finish. Lothian Road Runners are on board to assist. Everything on track. Note: this is the first event with the Masters age group reverting to 40, for both males and females.
- b) RRCC2009-31: RM/AJ/MJ – Road Championships: It was agreed that Tom Ferrington would be co-opted onto the Commission to drive the road racing plan for 2010 and beyond.

FVH will set the course for the same fee as 2009 with the start/finish area being built by Jim's team. AJ is awaiting a map from Andy Ronald who has specified 18 marshals although FVH cannot provide all. The inflatable gantry will be used and no officials to be in the vicinity when this is being erected/dismantled. RT requested to organise and erect signage.

Finally, it was agreed that thought be given to better ways of organising the District Commissions that capitalised on the use of email contact / consultation and reduced the need for meetings in view of these being poorly attended.
