**6. Finance**

6.1 Graham Sword provided an update on the budget and in particular noted that expenditure was well within the available resources.

**7. Ultra Trail Events**

7.1 MJ presented the paper on this growing area of the sport. An Ultra Trail Championship had been proposed by Adrian Stott which could be held within the Highland Fling event on 30/4/11. Agreed this would be the Scottish Championship and Trial for the Commonwealth Mountain and Ultra Running Championship event scheduled for 23 – 25 September 2011 in North Wales.

7.2 Selection for the 24 hour race in Llandudno was discussed along with arrangements for the Anglo-Celtic Plate which were noted. Discussion also on a possible World 24 hour event being staged in Scotland in 2013 which would be considered further.

7.3 Discussion concluded with agreement to work towards the organisation of an Ultra Trail Championship event by Scottish Athletics. **Action: RRCC2011-2: MJ/AS/AJ**

7.4 MJ also referred to a Commonwealth Games demonstration event which could be arranged for 2014. This was noted meantime.

**8. Stewart's Grand Prix Series**

8.1 Tom summarised the background to the paper and the need to progress arrangements with a degree of urgency. The meeting had taken place in October and agreed the Grand Prix would be stripped back to 5 races consisting of Stirling 10k; Tom Scott 10m; Dunfermline Half and Inverness Marathons and a 5k yet to be agreed. Tom was urged to secure the agreement of his group on race distance/choice, following which Alex would contact race organisers to confirm arrangements **Action: RRCC2011-3: TF/AJ**

8.2 The events already agreed were also nominated Scottish Championships. Discussions were taking place with Fiona regarding the JogScotland event at Glasgow Green to incorporate the 5k race. It was suggested Tom make contact with Alastair Currie on this.

8.3 It was proposed that there should be an even split in prize money between road and cross country. This was agreed as £750 for the top prize through to £30 for 10<sup>th</sup> place. It was noted all winning athletes will be given T-shirts and possibly hats to be worn for publicity photographs against the Stewart's background. This is a contractual requirement which athletes will need to comply with or points would be withdrawn.

**9. Medals at Masters Championship**

9.1 A paper had been discussed at the October meeting. Masters Championships will be held in 5 year categories for athletes on or over 40 on the day of the race. Athletes will compete only in their own 5 year age category but races may be combined for brevity. From Jan 2011 the following will be adopted: M40, M45, M50, M55, M60 will run together over 8,000 metres; All women + M65, M70 etc will run together over 6,000 metres. **Team medals** will be awarded as follows: 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place medals for teams of 4 to in the men's M40-M60 race; 1<sup>st</sup> place medals for a team of 3 in the men's race for combined M50, M55, M60 with the proviso that anyone winning a medal in the M40-M60 team race may not count in this one. In calculating the team scores all M40, M45 athletes and all medallists in the men's M40-M60 race will be removed from the results before allocating finishing positions; 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place medals for teams of 3 to count in the women's race; The Teviotdale Harriers Shield will be presented to the 1<sup>st</sup> team in the men's M40-M60 race; **Individual medals:** 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place medals will be awarded in all 5 year age categories; The Jock Simple Quaich will be presented to the 1<sup>st</sup> finisher in the M40-M60 race.

9.2 The above arrangements were proposed and agreed as rules for medals in Masters' Championships. **Action: RRCC2011-5: AJ**

12.1 Race programming was discussed to maximise the benefits to athletes of the flow of championships across the winter season. Options to be considered further were to relocate the 4k championships to mid-November following the district and national cross country relays. **Noted**
