- 6.1 Team Manager's Report noted. AJ advised discussions had taken place on the change of selection race from the National CC Championships to the Young Athletes Road Races to provide selection for a road event from a road event. Agreed this would be forwarded to the National Endurance Coach as advice from the Commission on the basis of first 4 from the YARR and remaining 2 on form. **Action: RRCC2011-15: AJ**
- 7. Fixtures / Championships**
- 7.1 National Cross Country Relays - RC advised North Lanarkshire support for Cumbernauld for 2011/12 Winter Season has been confirmed. Lead now North Lanarkshire Leisure, contact Yvonne Murray-Mooney. **Action: RRCC2011-16: RC**
- Route / course setting discussed and the role played by Jim Young and Bob Reid was noted and commended. For future events, a satellite map of the course is required. **Action: RRCC2011-17: AJ**
- 7.2 RC has approached Falkirk Council regarding use of Calendar Park for National Cross Country Championships in 2011/12 season. Follow-up action to be taken. **Action: RRCC2011-18: RC**

8. Competition Season

8.1 MP presented the paper which had previously been circulated and the following points were noted:-

- a) Introduction of a fallow weekend (Competition week 4) to allow for championship cancellations due to inclement weather
- b) The 4k championships will now be linked to the cross country relay season and take place in Competition week 44 (November)
- c) Other amendments to structures allowed for better alignment of the district, national, inter district and inter county cross country championships
- d) The inter district road 10k is again incorporated within the Great Edinburgh 10k on 2nd October 2011
- e) The summer road season still requires to be reviewed

8.2 The paper was agreed and noted that the programme remains a work in progress. AJ to write to JMacD advising Commission has requested retention of fallow date.
