**1. Chairman's Welcome and Opening Remarks**

- 1.1 Ron welcomed everyone to the meeting including Stephen Maguire, SAL's new Director of Coaching to his first meeting of the Commission and invited him to introduce himself.
- 1.2 Stephen outlined his background to coaching which included periods in Florida and Ireland, as well as time spent as personal coach to Jason Smith, recently successful in the Paralympics.
- 1.3 Ron also extended a welcome to Clare Barr who may be joining the Commission in the near future.
- 1.4 For the benefit of those attending their first meeting, Ron outlined the process and format adopted by the Commission which ensured meetings were focused and structured. He advised that a revised agenda for tonight's meeting had been prepared, then invited any additional agenda items to be starred.

**3.5 Action Updates:**

- a) **Action: RRCC2012-7: RM/AJ→MJ/MP:** Inter–District Championships and Nova. Nigel advised on recent communications with Nova which suggested a meeting in Edinburgh in mid-October to discuss/resolve.
- b) **Action: RRCC2012-32: RM/AJ/Fife AC** – 15K Trail Race. Ron has had discussions with Fife AC and advised that a trail venue has been identified. Funding and finance have yet to be agreed. Nigel will have discussions on SAL personnel to be involved and advise on outcome. The preferred timescale for this event is July/August/September 2013 and the growth potential is acknowledged.
- c) Medals – related to another action, Nigel raised the question of the quality of SAL medals. This had been raised at other meetings and he sought the views of the RR&CC Commission. No-one had received any complaints, particularly those who had been involved in presentations over recent years.

**4. Championships**

- 4.1 Alex advised that arrangements for Championships are well advanced and progressing with the exception of the Young Athletes Road Race Championships. The preferred venue of Rouken Glen Park is not available due to improvement works taking place. The option of Riccarton/Herriot Watt University is to be explored. **Action: RRCC2012-45: AJ**

- 6.1 Ron outlined the background to this item and referred to papers issued by Mike Johnston and Mark Pollard to a previous meeting. Participation levels have been increasing steadily for the past 10 years and the Commission should consider how best it can measure and monitor growth in this area.
- 6.2 Mark presented some suggestions for consideration in relation to participation in Euro and World Cross Country events; English 6/12 stage relays and suggested that the aim was to set targets across a range of events in the season that would target area, club and athlete performance.
- 6.3 To conclude discussions, Ron invited all Commission members and attendees to suggest one target for consideration and forward this to the Secretary in advance of the next meeting. **Action: RRCC2012-47: All**
- 7. Athletes**
- 7.1 Discussion took place on athletes competing and resident in Scotland but not cleared for selection for Scottish teams by the IAAF. Ron agreed to check with Shettleston Harriers on the position of their athletes' applications. Nigel to check on progress at a higher level. **Action: RRCC2012-48: RM/NH**
- 8. Entry to Championship Races for International Athletes**
- 8.1 An issue had arisen in relation to an athlete selected for Scotland in the recent International at Stirling but not entered in the race. It was noted that all selected athletes had been advised of their need to enter the event to qualify for Grand Prix/Championship points and prizes but this had not been followed through by some individuals. This will be raised at the next meeting of the Road Running Grand Prix Sub-Committee. **Action: RRCC2012-49: TF**
