7. Additional items tabled:

Masters XC Teams – all masters athletes to run in their own age groups for team prize calculation. This will be announced at the start of the next XC season.

National XC Females teams – proposal to increase numbers to qualify to 6 was defeated on a majority vote. 2020 was identified as a date to work towards for possible equalisation with a period of member consultation and feedback in advance.

Scottish Marathon Championships – calculation of results is very challenging because London organisers will not provide results in a helpful format for extracting this information. Welsh and English bodies face the same challenge. Discussion re. using a Scottish event when London is not being used as a championship qualifying race.

Road Race Management Group – JR advised group of discussion and logistical and monetary impracticalities of the approach in Scotland. Compromise is for race support resource staff to be available from Aug/Sept via Scottish Athletics.
